Member that the North-Eastern Railway, when it was joined with the N.F. Railway had a holiday home at Kurseong but that had to be taken over by the Engineer-in-Chief's Administration. They are now actually negotiating to purchase som<sub>e</sub> property at Naini Tal to establish their home there.

## RURAL WATER SUPPLY AND SANITATION SCHEME IN MYSORE STATE

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR); The Government of Mysore submitted estimates for

piped water supply schemes in January, 1960 for approval under the National Water Supply and Sanitation Programme (Rural). As the estimates related to individual villages and did not conform to the accepted pattern for the schemes to be approved under that programme, it was not possible to approve the schemes. The State Government were informed accordingly on 18th March, 1960.

The scheme submitted was for individual villages and, therefore, they could not be approved under the National Water Supply scheme but there is provision under the Development Fund where-from even single villages could be helped.

(b) how many of them have opted for the Jodhpur State and how many for Indian Railways; and

(c) whether those who opted for Indian Railways are paid emoluments on the basis of present Railway scales or on the basis of the present State scales or they have not been given any scale since the date of integration?

THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) 4 Assistant Surgeons, 6 Dispensers, 1 Midwife, 1 Sanitary Inspector and 1 Clerk.

(b) All have opted for service with Indian Railways, except 1 Assistant Surgeon who has since retired.

(c) They are being governed by the Rajasthan Government scales of pay.

SHRI JAI NARAIN VYAS: When they have opted for Railway service, how is it that they are still governed by the Rajasthan Government rules?
