ROAD-RAILERS

254. SHRIMATI SAVITRY DEVI NIGAM: Will the Minister of RAILWAYS be pleased to state:

(a) what are the special features of Road-Railers scheme; and

(b) whether the Indian Chamber of Commerce has raised any objections against this scheme?

THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) Road-Railers are special trailer type vehicles with retractable wheels, which make them suitable for use on rails as well as roads. The technical and other aspects of road-railers as in use in other countries, are proposed to be examined to determine if, and how best, such vehicles can be adapted for use in India.

(b) The Indian Chamber of Commerce has asked for detailed information regarding economics of production and operation of Road-Railers before submitting their views.
