t [EMPLOYMENT or VAIDYA-CUM-BASIC DOCTORS IN THE NATIONAL HEALTH **PROJECTS**

*349. SHRI NAWAB SINGH CHAUHAN: Will the Minister of HEALTH be pleased to state:

- (a) whether there is any scheme under Government's consideration to make available qualified vaidya-cum-basic doctors for the National Health Projects; and if so, by when this scheme will come into operation;
- (b) what qualification prescribed for candidates to be trained under the scheme and what will be the syllabus and duration of the training;
- (c) whether candidates will be given training free of charge; and
- (d) the number of Vaidyas who will be trained -under this scheme every year?]

स्वास्थ्य मंत्री (श्री डी० पी० करमर-कर): (क) से (घ) यह योजमा विचारा-

UTHE MINISTER OF HEALTH (SHRI D. P. KARMABKAR): (a) to (d) The scheme is under consideration]

श्री नवार्बासह चौहान: यह योजना क्या है जो कि विचाराधीन है ? क्या इसकी कुछ मोटी मोटी बातें ब्राप बतला सकते हैं ?

श्री डी० पी० करमरकरः यह योजना ऐसी है कि जिनको आयुर्वेद में ज्ञान होता है और जो आयुर्वेद में ज्ञान होता है और जो आयुर्वेद में तरक्की किये हुए होते हैं उनको यह सुविधा हो कि वे कोई बुनियादी माडनें मेडिसिन का इम्तिहान दें और उसकी उन्हें जानकारी ठीक तरह से हो । ऐसी योजना है कि जो कि विचाराधीन है ।

श्री नवाबिंसह चौहान : इस योजना के ऊपर कब तक श्रन्तिम निर्णय हो जायगा श्रीर क्या यह उम्मीद की जा सकती है कि यह चालू हो सकेगी श्रीर अगर चालू होगी तो कब तक चालू होगी ?

श्री डी० पी० करमरकर : उम्मीद तो की जा सकती है लेकिन कब तक यह कहना मृश्किल है।

श्री नवार्बासह चौहान : क्या इससे तीसरी पंचवर्षीय योजना में कुछ फायदा लेना है या वैसे ही महज ग्रस्तवारों में निकालने के लिये इसकी चर्चा की जा रही है?

श्री डी॰ पी॰ करमरकर : हमें तो जल्दी से जल्दी इस योजना का उपयोग करना है श्रीर जैसा कि माननीय सदस्य ने कहा अख-बारों के बारे में तो मेरा तो मिनिस्ट्री को कड़ा आदेश है कि कभी अखबारों पर न जायं, जिस तरह कि माननीय सदस्य खुद जाते ।

श्री नवाबसिंह चौहान : मैंने अखबार के आधर पर ही यह प्रश्न लिखा है। यह हो सकता है कि यह अब अखबारों में न जायं लेकिन आप अखबार में यह निकाल चुके हैं। क्या माननीय मन्त्री जी यह बता सकेंगे कि किस तरीके पर यह खबर बाहर गई?

श्री डी० पी० करनरकर : माननीय सदस्य या श्रीर उनके जैसे जो लोग हैं उनकों किसी तरीके से इत्तिला पहुंच सकती है। न हम अखबार में जाते हैं श्रीर न हमारी यह इच्छा है लेकिन कभी कभी अखबारों में ऐसी चीज श्रा जाती है। कह नहीं सकता कि किस तरीके से जाती है, कभी मुहक्मे से जाती है श्रीर कभी श्रीर तरह से।

SHRI B. K. P. SINHA: What are these vaidya-cunvbasic doctors? What distinguishes them from the other doctors?

SHRI D. P. KARMARKAR: We are seeking to have a combination of both the doctors. Now, vaidyas are not taken in service at all except in minor services. But we do believe that Ayurveda has a distinct contribution to make. By itself it cannot stand. Therefore, we are trying to evolve a medical personnel which can give the best from both the types.

SHRI M. M. MEHTA: In the D. F. A. M. course the Materia Medi-ca is not being taught and in spite of that these diploma-holders are engaged by Government and asked to practise allopathy. How is this?

SHRI D. P. KARMARKAR: It is not a fact. In the integrated course for the G. F. A. M. Degree and for this particular diploma, there is a course in modern medicines included, though it is not as ample as the M.B.B.S, course, they got the necessary knowledge to the extent it can be used. They are used, not at the lowest rung, but at the second rung they are used and it adds to their usefulness.

SHRIMATI SAVITRY DEVI NIGAM: In a number of States such training has been given to these doctor-cum-vaidyas and this training has proved very successful. So, may I know why this project is taking so much i time?

SHRI D. P. KARMARKAR: The whole attempt is to see to it that the movement or the propagation of Ayurveda is made on the correct lines. We do not believe that Avurveda by itself will satisfy the requirements of the situation. Therefore my hon. friend need not get impatient we are trying to add to the training of persons who have purely those Ayurvedic education or training and to see to it that they are made capable of rendering more useful service.

SHRIMATI SAVITRY DEVI NIGAM: My question was different.

Mr. CHAIRMAN: No question of patience or impatience. It is something else

SHRIMATI SAVITRY DEVI NIGAM: Yes, Sir. My question was whether this integrated course for vaidya-curn.-basic doctors in the various States like Uttar Pradesh and others, has proved successful or not?

MR. CHAIRMAN: She wants factual information. Has it been successful in Uttar Pradesh or not?

SHRI D. P. KARMARKAR: I am not sure, Sir, for in U.P. experimentation was there for one year at one place, for two years in another place and I am not sure where they will be trying it tomorrow or next year.

CHANDRAVATI SHRIMATI KHANPAL: I want to know how this course will be different from the integrated course which is already in vogue according to which they are taught both Ayurveda and allopathy?

SHRI D. P. KARMARKAR: In institutions where they give courses of training for four or five years resulting in diplomas and degrees, it is also desired to give purely Ayurvedic men a background in public health and modern medicine to enable these .persons to practise better.

SHRI B. K. P. SINHA: What are the institutions and universities giving training for these vaidya-cttm-

basic doctors and what is the number annually trained in these institutions?

SHRI D P. KARMARKAR: For facility. I shall pass on a good report by Dr. Upal—it is a report of 150 pages and then my hon, friend may kindly ask further questione and I shall be happy to supplement the information.

GOPIKRISHNA VIJAIVA-RGIYA: I want to know whether the hon. Minister is aware that since a long time past in the Banaras University they have been having a course as A.M.S. Is it in the view of the Minister?

SHRI D. P. KARMARKAR: It is in -the view of the Minister, Sir. But that degree disappeared last year, because they gave another thought to the question and now they have a full-fledged medical college with a section for Ayurved. My hon. friend's information is at least one year old.

SHRI K. K. SHAH: Is there facility for research in the Ayurveda section just as they have for the L.C.P. course?

SHRI D. P. KARMARKAR: Facilities for research in Ayurveda are given to people who possess no degree, but who possess a iaculty for Ayurveda. That question is separate from this.

SHRI K. K. SHAH: L.C.P.Ss; are given facilities for research in allopathy. Degree holders in Ayurved have taken a course in Allopathy. But they are denied all facilities for research.

SHRI D. P. KARMARKAR: I am going one step further than what my friend wants. Even if a person possesses absolutely no degree, like my hon. friend, we are prepared to agree, provided they are competent to carry on research.
