

SHRI GOPIKRISHNA VIJAIVAR-GIYA: Is the Government sure that the plane did not come from China or any other country to drop, the machines?

SHRI AHMED MOHIUDDIN: They were not dropped by any plane; they were parts of radie-sonde instruments contained in the balloons sent up from the observatory at Gwalior.

PANCHAYATS IN DELHI

*335. SHRI FARIDUL HAQ ANSARI: Will the Minister of COMMUNITY DEVELOPMENT AND CO-OPERATION be pleased to state;

(a) whether there is any proposal under Government's consideration to enhance the powers of the Panchayats in the Union Territory of Delhi; and

(b) if so, what are the details of these proposals?

THE PARLIAMENTARY SECRETARY TO THE MINISTER OF COMMUNITY DEVELOPMENT AND COOPERATION (SHRI S. D. MISRA): (a) Yes, Sir.

(b) The proposals relate to the transfer to Panchayats of certain civic and municipal functions in the rural areas of Delhi hitherto within the jurisdiction of the Municipal Corporation under the Municipal Corporation Act, 1957 and entrustment to them of wider developmental functions by the Delhi Administration.

SHRI FARIDUL HAQ ANSARI: May I know, Sir, what are those functions which have so far been discharged by the Municipal Corporation and which the Ministry now proposes to make over to the Panchayats?

SHRI S. D. MISRA: Sir, these functions are mostly civic; they relate to certain civic amenities. They relate to construction and maintenance and cleaning of drains, construction and maintenance of municipal works and the like.

SHRI FARIDUL HAQ ANSARI: May I know, Sir, whether there is any proposal before the Government to give them power to try the small civil and criminal cases in the villages?

SHRI S. D. MISRA: That power is already given to the Nyaya Panchayats in the Delhi Panchayat area.

FIXATION OF PAY OF DOCTORS UNDER C.H.S. SCHEME AS RECOMMENDED BY PAY COMMISSION

*337. SHRI P. N. RAJABHOJ: Will the Minister of HEALTH be pleased to state:

(a) whether it is a fact that the Pay Commission's recommendations regarding the salaries of doctors employed by Government under the Contributory Health Service Scheme have not so far been fully implemented by Government; and

(b) if so, what are the reasons for non-acceptance of certain allowances recommended by the Pay Commission?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): (a) Pay Commission have not made any specific recommendations for doctors employed by Government under the Contributory Health Service Scheme.

(b) Does not arise.

I should like to add that when the Central Health Service Scheme gives consideration in respect of the grades about which the Pay Commission have made suggestions, then those scales will apply to these doctors also like everybody else.

श्री पा० ना० राजभोज : क्या माननीय मन्त्री जी कृपा करके बतायेंगे कि क्या यह बात सच है कि सी० एच० एस० के डाक्टरों का

पे स्ट्रक्चर ऐसा है कि सीनियर डाक्टरों को कम पैसा मिलता है और नये डाक्टरों को ज्यादा तनखाह मिलती है क्योंकि वे नये स्केल के मुताबिक भर्ती किये गये हैं ?

श्री डी० पी० करमरकर : कभी कभी ऐसा हो सकता है । जो नये स्केल के मुताबिक भर्ती होते हैं उनको ज्यादा तनखाह मिलती है और जिनका प्रवेश पुराने स्केल में हुआ है उनको कमती तनखाह मिलती है ।

श्री पा० ना० राजभोज : क्या यह बात सच है कि स्केल्स में तथा अन्य वर्किंग कंडीशंस में सी० एच० एस० के डाक्टरों और हास्पिटल स्टाफ में भी ऐसी डिसपैरिटी है ?

श्री डी० पी० करमरकर : अलग अलग चीजें होती हैं, अलग अलग नौकरियां होती हैं और उनमें डिसपैरिटी तो होती ही है ।

SHRI SATYACHARAN; May I know, Sir, whether there is any proposal on behalf of the Government to effect uniformity in their salaries since they belong to the same cadre?

SHRI D. P. KARMARKAR: The question cannot be related to advantages to be given by the Pay Commission's recommendations. As I said, when the Central Health Cadre comes into existence, all these doctors will come into those cadres and all the advantages that have been recommended by the Pay Commission will be given to them.

FULFILMENT OF ORDERS PLACED WITH HINDUSTAN SHIPYARD

*338. SHRI P. N. RAJABHOJ: Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state;

(a) whether it is a fact that the orders placed with the Hindusthan Shipyard, Visakhapatnam are not fulfilled in time for want of foreign exchange; and

(b) if so, what action Government have taken to meet the situation?

THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI RAJ BAHADUR):

(a) No.

(b) Does not arise.

श्री पा० ना० राजभोज : क्या माननीय मन्त्री जी कृपा करके बतायेंगे कि हिन्दुस्तान शिपयार्ड के विकास के कार्यक्रम के लिए सरकार ने अब तक कितने पैसे दिये हैं ?

श्री राज बहादुर : पहल पांच जहाजों के लिए १ करोड़ १५ लाख रुपया दिया गया । उसके बाद तीन जहाजों के लिए २ करोड़ ८५ लाख रुपया दिया जाने का विचार था, एक जहाज के लिए ६३ लाख रुपया दिया गया । अब उन्होंने ५ और जहाजों के लिए देने का विचार प्रगट किया है ।

श्री पा० ना० राजभोज : क्या यह बात सच है कि हिन्दुस्तान शिपयार्ड को सिवाय छोटे छोटे आइटम्स के पूरे बेसिल्स बनाने के आर्डर नहीं मिल रहे हैं ?

श्री राजबहादुर : जी, यह सच नहीं है ।
