three main supply presses or stores: the Post and Telegraph Stores at Calcutta, Aligarh and Nasik. There is some shortage at Aligarh and Calcutta. The Nasik Stores is some sort of a complementary store for the time being.

SHRI FARIDUL HAQ ANSARI: May I know whether the hon. Minister is aware that according to a letter published in the "Statesman" of the 3rd February even postal orders are not available in most of the post offices of Calcutta?

SHRI RAJ BAHADUR: I am not quite aware of that particular letter, but it is a fact that there has been some difficulty in the availability of even essential forms. There are esential forms as distinct from nonessential forms, and that might be a fact in regard to postal orders, but that would require investigation.
