THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) No Sir, except on the Purna-Basim Section.

(b) The Purna-Basim section is a newly opened section. The train services comprise of one passenger and one mixed train each way. The mixed trains have to perform shunting operations at intermediate stations which affects their punctuality. In the time table to come into force from 1-4-61 it is proposed to discontinue running of mixed trains, which step is expected to ensure a satisfactory standard of punctuality.
