†[THE MINISTER OF MINES OIL (SHRI K. D. MALAVIYA): (a) and (b) The position on is that the structure has been found to be far more complicated than had been indicated by seismic studies. The thickporosity and content oil etc. in the oil sands is not uniform. There has also been faulting or dislocation of sand beds. drilling is rendered complicated on account of high pressure gas, water and abnormal temperatures. An exact delineation of the ture or of the oil sands has, fore, been found to be very difficult on account of unpredictable conditions which are being encountered.]

RECOMMENDATIONS OF THE ADVISORY
COMMITTEE OF LIBRARIES

*3. Shrimati SAVITRY DEVI NIGAM: Will the Minister of Education be pleased to state the number of recommendations of the Advisory Committee of libraries which have been fully accepted and implemented by Government?

THE MINISTER OF EDUCATION (DR. K. L. SHRIMALI): A statement is laid on the Table of the Sabha.

STATEMENT

The Government of India is concerned with 17 recommendations of the Advisory Committee for libraries. The following nine recommendations have been accepted and instructions to various agencies concerned have been issued for their implementation:—

1. Library Service should be free to every citizen of India. Chapter IV Recommendation No. 1.

2. The library pattern in the country should consist of National Library, State Central Libraries District Libraries, Block Libraries and Panchayat Libraries.

Chapter IV, Recommendation No. 2.

3. Library associations are essential to the development of library movement and State Governments and Government of India should encourage development of strong library associations.

Chapter V, Recommendation No. 2.

4. Government should give financial assistance to library associations for the following purposes: Chapter V, Recommendation No. 3.

- (a) rent for premises of headquarters office;
- (b) remuneration of one wholetime or parttime Secretary or office clerk;
- (c) project of general usefulness to library movement which Government may like to sponsor.
- 5. Public libraries in the country should cooperate with one another public libraries, as well as subscription
 libraries, school libraries, college libraries
 departmental and
 research libraries and
 university libraries etc.

Chapter V, Recommendation No. 7.

. Pending establishment of efficient reference sections in public libraries, Government departmental and research libraries should assist them in compiling

Chapter V, Recommendation No. 10. annotated booklists on their special subjects and in answering reference enquiries from the public etc.

7. The University library should co-operate with the public library system by:

Chapter V, Recommendation No. 11.

- (a) issuing booklists on subjects of interest to certain groups in the public.
- (b) admitting as regular members the more serious minded readers among the public.
- (c) perform reference functions of the State Central Library, where these libraries are not yet established.
- 8. The Central Ministry of Education should organise every year at least one all-India seminar or a workshop of librarians and liberally subsidise at least two regional seminars;

- Chief librarians at all levels should be associated with the selection of staff at their level.

SHRIMATI SAVITRY DEVI NIGAM: May I know, Sir, how many regional seminars were organised during the year 1959-60 and also how much grant was given to the Library Association for this purpose?

Dr. K. L. SHRIMALI: Well, Sir, this is a different question. If the hon. Member puts a separate question, I shall answer it.

SHRIMATI SAVITRY DEVI NIGAM: Sir, it has been stated in this Statement against item No. 4(c) as follows:

"project of general usefulness to library movement which Government may like to sponsor."

May I know if any such project was sponsored by the Government during the year 1959-60?

DR. K. L. SHRIMALI: The hon. Member will see that this Statement deals with a number of recommendations. It is not possible for me now to answer each and every question on the floor of this House on all these recommendations. She will have to put me separate questions.

SHRIMATI SAVITRY DEVI NIGAM: Sir, I simply want to know if the Government, especially the Education Ministry, had sponsored any such project during the year 1959-60.

Dr. K. L. SHRIMALI: As I have already stated, Sir, the hon. Member will have to put a separate question on this.

- *7. Shri DAHYABHAI V. PATEL: Will the Minister of Education be pleased to refer to the answer given to Starred Question No. 354 in the Rajya Sabha on the 13th December, 1960 and state:
- (a) whether Government have since received a copy of the report of the Aligarh Muslim University Enquiry Committee;
- (b) if so, when it is to be made available to Members of Parliament; and
- (c) whether Government propose to take any action in the matter; if so, what?

THE MINISTER OF EDUCATION (Dr. K. L. SHRIMALI): (a) Yes, Sir.

- (b) The University has taken steps to print the copies of the Report and the same will be made available to Members of Parliament as soon as received.
- (c) On receipt of the Report, the University authorities took steps to call a special meeting of the Executive Council on the 12th and 13th February, 1961 to consider the Report and to formulate its views thereon. Government will examine the Report in the light of the Executive Council's comments, when received, with a view to deciding further course of action.
