SHRI B. N. DATAR: Sir, the question of the Scheduled Castes and the Scheduled Tribes does not arise here at all. This is only a matter of promotions.

SHRI B. N. DATAR: I have not got the figures.

MR. CHAIRMAN: That is a different answer.

SCHOLARSHIP SCHEME FOR THE CHILDREN
OF THE DEFENCE SERVICE PERSONNEL
AT THE LAWRENCE SCHOOLS, SANAWAR
AND LOVEDALE

*497. SHRI ARJUN ARORA: Will the Minister of Defence be pleased to state:

- (a) whether there is a scheme for awarding scholarships to the children of the Defence Service personnel at the Lawrence Schools at Sanawar and Lovedale; if so, what are the details thereof and how are the recipients selected; and
- (b) whether the list of recipients is released for publication; if not, why not?

DEPUTY THE MINISTER DEFENCE (SARDAR S. S. MAJITHIA): (a) Yes, Sir. There is at present provision for scholarships to cover 20 per cent. of the children of Defence Services personnel on the rolls of these two schools. The selection is made out of the list of candidates who are successful in the All India Merit Scholarship Examination conducted by the Ministry of Education. Other details are given in the statement which is laid on the Table of the House.

(b) No, Sir. The necessity for publication of the list has not been felt. The parents/guardians of the recipients of the scholarships are informed.

STATEMENT

There shall be scholarships reserved for the children of Defence Services Personnel in the two Lawrence Schools and the expenditure on these shall be debited to the Defence Services Estimates.

- 2. The number of scholarship holders shall be 20 per cent, of the number of seats actually filled by the children of Defence Services Personnel (40 per cent, of the seats are reserved for them in each School).
- 3. (i) The selection of scholars for the grant of scholarships will be made by the Ministry of Defence from the list of candidates (children of Defence Services Personnel) who have come out successful in the All India Merit Scholarship examination by the Ministry of Education but who are not awarded the Education Minis-Scholarships for want of The children of the vacancies. Defence Services Personnel will be graded in order of merit and scholarships will be awarded to them upto the number of Scholarships available in the two Lawrence Schools. this purpose, the Headmasters of the two Lawrence Schools will furnish the number of scholarships available (on the basis of 20 per cent, of the number of seats actually filled and estimated to be filled by the children of Defence Services Personnel) at the Schools every year before the scholarship tests are held by the Ministry of Education.
- (ii) Children who have completed the age of 5 years but have not completed the age of 12 years on the 15th July of the year of examination will be eligible for the grant of these

- scholarships. Children already in the Schools, may, if their parents so desire, will be allowed to compete for the scholarships.
- (iii) A scholarship once awarded to a pupil will continue to be awarded to him throughout his stay in the school, provided—
 - (a) he obtains a minimum aggregate percentage of marks at 50 per cent at the end of each year,
 - Note.—A scholar not obtaining an aggregate of 50 per cent. marks, may continue to enjoy the benefit of the scholarship, if the Headmaster has strong reasons to recommend continuation.
 - (b) he is not reported on adversely regarding discipline,
 - (c) he is not otherwise eligible for the continuance of the scholarship on the basis of the income of his parents, (see below). Scholarships once awarded will not be withdrawn, if in a particular year, number of scholarships already awarded is more than 20 per cent. of the seats actually filled in by the children of Defence Services Personnel.
 - (d) if any scholarships are forfeited in accordance with the Scholarship Rules, not more than two may, on the recommendation of the Headmaster, be awarded by the Ministry of Defence according to the Scholarship Rules, to pupils in the Schools above the age of 12.
- 4. The value of the scholarships mentioned in paras above will be as follows:—
 - (a) If the salary of parents is Rs. 1,200 p.m. or above—No exemption from fees.

- (b) If the salary of parents is

 Rs. 600 p.m. to Rs. 1,199
 p.m.—Exemption from half
 School fees.
- (c) If the salary of parents is from Rs. 251 p.m. to Rs. 599 p.m.—Full exemption from School fees.
- (d) If the salary of parents is from Rs. 101 p.m. to Rs. 250 p.m.—Full exemption from School fees. The scholar will also be given a clothing allowance of Rs. 150 per annum.
- (e) If the salary of parents is Rs. 75 p.m. to Rs. 100 p.m.— Full exemption from School fees and clothing allowance as at (d) above. The scholar will be paid a travelling allowance, as below, for the journey to join his School at the commencement of each term (including the journey to join the School the first time, and the journey from School to his home or other place of normal residence whichever is nearer) at the end of each term-
 - Where no school party is organised, third class railway fare with a return fare for the escort.
 - If there is a school party, the scholar must join it; in the case of onward journey to the School, he will join the party at the point nearest to his home and in the case of onward journey from the school he will travel with the party upto the point nearest to his home.
 - (f) If the salary of parents is less than Rs. 75 p.m.—Full exemption from the School fees and clothing and travelling allowances as at (e) above. The scholar will also be supplied by the School with the school uniform, according to schedule, and will be given pocket

money, which will include expenditure on essential toilet articles, at the school rate.

Oral Answers

N.B.-"School fees" will include all charges compulsorily paid by all students to the school including boarding and lodging, except uniform and clothing fees if in any school such fees are collected separately; any money payable by any student on account of any special or personal services provided to him at request will not be counted as and included in "School fees" for purposes of these scholarships

SHRI ARJUN ARORA: May I know as to why the list is not published, Sir?

SARDAR S. S. MAJITHIA: As I said in the reply it has not been found necessary because the parents the guardians of the scholarship holders are always informed.

SHRI N. M. LINGAM: May I know the number of children belonging to persons serving in the Defence Services who are enjoying these scholarships at the present moment and the number of such pupils on the rolls?

S. MAJITHIA: SARDAR S. The number of scholarship-holders Sanawar at the moment is eight and 12 at Lovedale. The number of boys of the Defence Services Personnel is 152 at Sanawar and 75 at Lovedale.

SHRI N. M. LINGAM: May I know why full advantage is not being taken of the facilities afforded by the schools in regard to scholarships?

SARDAR S. S. MAJITHIA: All those who are qualified do get scholarships and rules are laid down in this regard which are given in the statement placed on the Table of the House.
