**Increase in irrigation tax**

4017. SHRI KALRAJ MISHRA: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that certain State Governments, including Madhya Pradesh and Chhattisgarh have raised many-fold the irrigation tax per acre leviable on farmers;

(b) if so, whether Government have issued any broad guidelines to State Governments about State-levies and taxes imposed on farmers, to help the farmers out of the financial and tax-burden and to protect them against situations leading them to commit suicides; and

(c) if so, the details in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRI S.S. PALANIMANICKAM): (a) to (c) Irrigation being a State subject,

the rates for water charges etc. are fixed by respective State Governments. Several State Governments have revised the water rates in recent years. The water rates vary considerably from State to State. Latest State-wise water rates for flow irrigation and lift irrigation are at Statement I and II respectively.
