THE DEPUTY MINISTER OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI MENON>: (a) Shri C. S. Jha, India's Permanent Representative to the United Nations, supported United Nations action in the Congo, which was undertaken by the Security Council at the request of the Central Government of the Republic of the Congo.

- (b) While supporting the action of the United Nations in the Congo, Shri Jha did not make any specific mention of the role of the U.N. Secretary-General, Mr. Dag Hammarskjold, in regard to the developments in the Congo.
- (c) A copy of the text of Shri Jha'B statement on the Afro-Asian resolu tion on the Congo, made during the Special U.N. Session, has been placed on the Table of the House.

STATEMENT

Text of the statement made by Shri C. S. Jha, Permanent Representative of India to the United Nations, on the Afro-Asian Resolution on Congo during the fourth emergency special session.

Mr. Jha (India).—This emergency special session of the General Assembly has been called by the Security Council to deal with the situation regarding which the Council itself was unable to reach a decision. In some ways therefore this session may be
