140. SHRI M. BASAVAPUNNAIAH: Will the PRIME MINISTER be pleased to state:

(a) whether his attention has been drawn to a news item which appeared in the weekly entitled "German News" published by the West German Embassy in its issue of the 22nd October, 1960 to the effect that the West German Chancellor is reported to have spoken of "accord in the political attitude towards fundamental questions" as a result of talks between him and the Prime Minister at Bonn Airport on October 10, 1960; and

(b) if so, whether the report is correct?

THE PRIME MINISTER AND MINISTER OF EXTERNAL AFFAIRS (SHRI JAWAHARLAL NEHRU): (a) and (b) The talks between the Prime Minister and Chancellor Adenauer at their brief meeting at the Bonn airport were chiefly concerned with the preservation of peace and the avoidance of anything that might increase world tensions. Both of them agreed that peace should be preserved and maintained and nothing should be done which might result in increasing tension. This was stated by the Prime Minister subsequently to newspapermen at the airport when Chancellor Adenauer was present. The Chancellor did not make any statement then.
