were about 8 to 10 in number. The G.R.P. Khagaria have registered a case under section 395 I.P.C. and have taken up investigation. As the passengers alleged to have been robbed did not themselves make a report to the police, and the report was made by a third party viz. an Organiser of the Village Volunteer Force, it has not been possible to ascertain the actual amount robbed nor are the names and addresses of the persons actually robbed known.

## CAPSIZING OF DREDGER NEAR CALCUTTA

- \*337. SHRI S. C. DEB: Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state;
- (a) whether it is a fact that the 1300-ton dredger, Lake Fifthian, capsized at Falta-Hooghly Point Reach, down Calcutta at night on the 18th November, 1960;
- (b) if so, how the disaster occurred and what measures Government have taken in this respect; and
- (c) what are the losses caused to life and property as a result of the disaster?

THE MINISTER OF TRANSPORT AND COMMUNICATIONS (Dr. P. SUBBARAYAN): (a) Yes, Sir.

- (b) The vessel was a dumb craft. It got out of control due to the unusually high spring tide, capsized and sank immediately. The Mercantile Marine Department have undertaken a preliminary enquiry into the accident. The findings of that enquiry are awaited.
- (c) Seventeen members of the crew lost their lives. The vessel has not so far been salvaged.

## Report by Mr. Posthuma on Bombay Dockyard

- (a) whether it is a fact that Mr. Posthuma, Managing Director of

Rotterdam Port, has arrived in India to advise on the increase of the depth of the Victoria Dock and other expansion programmes of Bombay Dockyard; and

(b) if so, whether any report has been or will be submitted by him?
