THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): (a) The World Health Organsiation team has completed it> study in India

(b) The team has submitted its report to the World Health Organisation. A copy of the report has not yet been submitted to the Government of India.

3. Prof. Owen Wade, Professor c Therapeutics;

all from the Queen's University 0 Belfast.

LATE DELIVERY OF MAIL AND TELEGRAMS IN ASSAM

- •475. SHRI PURNA CHANDRA SHARMA: Will the Minister oi TRANSPORT AND COMMUNICATIONS bt pleased to state:
- (a) why the delivery of mail and telegrams m Assam has become unusually late:
- (b) whether it is a fact that there is shortage of peons in the district pos>1 and telegraph offices; and
- (c) whether any complaint has been received and attended to in this regard from the post office of Now. gong?

THE MINISTER OF TRANSPORT AND COMMUNICATIONS (DR. P. SUBBARAYAN): (a) Owing to the civil disturbances in the State of Ajsam in July, 1960, the delivery of mails and telegrams in some cases was subjected to delay.

(b) and (c) It is not a fact that there is shortage of $peon_s$ in all district post and telegraph offices in Assam. Only one complaint regarding shortage of delivery staff in Nowgong Post Office was received and was duly

investigated. Six additional Postmen and one adult Messenger have since been sanctioned for this office.

SHRI PURNA CHANDRA SHARMA: Has not the Government received some complaints from other parts of Assam regarding delay in the delivery of telegrams and postal letters?

DR. P. SUBBARAYAN: Well, Sir, there is no complaint, a_s far as I am aware. What happened was that daring the disturbances, in the Brahmaputra Valley District it was not possible to deliver the post in time; it was intercepted on account of the riots that were raging there.

SHRI PURNA CHANDRA SHARMA: Is it not a fact that such delays have been occurring for the last two years? The delivery of mails was made twice during the day and now it is being made only once a day, and sometimes telegrams are received even 24 hours after the time of their receipt in the Telegraph Office.

DR. P. SUBBARAYAN: I am not aware of what the hon. Member says, but I may point out that telegrams do get delayed because there are over-headlines and sometimes there are disturbances also.

SHRI PURNA CHANDRA SHARMA: Does the hon. Minister think it advisable to take some steps to expedite the delivery of telegrams and letters— at least twice a day?

DR. P. SUBBARAYAN: That matter is being enquired into.

DR. RAGHUBIR SINH: May I know, Sir, 'if the hon. Minister is satisfied that since those disturbances ended, the position has been improving?

Dr. P. SUBBARAYAN: I have said so, Sir.

SHRI FARIDUL HAQ ANSARI: May I know whether it i_s a fact that there is a general complaint about the late

delivery of telegrams, money orders and express letters?

MR. CHAIRMAN: Not confined to Assam.

Dr. P. SUBBARAYAN: Not confined to Assam, Sir. As a matter of fact. Sir, they are all being enquired into. I am keeping it under a strict watch.
