investigated. Six additional Postmen and one adult Messenger have since been sanctioned for this office.

SHRI PURNA CHANDRA SHARMA: Has not the Government received some complaints from other parts of Assam regarding delay in the delivery of telegram<sub>s</sub> and postal letters?

DR. P. SUBBARAYAN: Well, Sir, there is no complaint,  $a_s$  far as I am aware. What happened was that daring the disturbances, in the Brahmaputra Valley District it was not possible to deliver the post in time; it was intercepted on account of the riots that were raging there.

SHRI PURNA CHANDRA SHARMA: Is it not a fact that such delays have been occurring for the last two years? The delivery of mails was made twice during the day and now it is being made only once a day, and sometimes telegrams are recived even 24 hours after the time of their receipt in the Telegraph Office.

DR. P. SUBBARAYAN: I am not aware of what the hon. Member says, but I may point out that telegrams do get delayed because there are over-headlines and sometimes there are disturbances also.

SHRI PURNA CHANDRA SHARMA: Does the hon. Minister think it advisable to take some steps to expedite the delivery of telegrams and letters— at least twice a day?

DR. P. SUBBARAYAN: That matter is being enquired into.

DR. RAGHUBIR SINH: May I know, Sir, 'if the hon. Minister is satisfied that since those disturbances ended, the position has been improving?

DR. P. SUBBARAYAN: I have said so, Sir.

SHRI FARIDUL HAQ ANSARI: May I know whether it  $i_s$  a fact that there is a general complaint about the late

delivery of telegrams, money orders and express letters?

MR. CHAIRMAN: Not confined to Assam.

DR. P. SUBBARAYAN: Not confined to Assam, Sir. As a matter of fact. Sir, they are all being enquired into. I am keeping it under a strict watch.

(b) the expenditure borne by the Government of India on the visit of the delegation?

THE MINISTER OF AGRICULTURE (DR. P. S. DESHMUKH): (a) A statement giving the information is placed on the Table of the Sabha.

(b) The total expenditure involved to the Government of India on this delegation was about RJ. 16,176. Rs. 12,717 out of this were spent on return Air Fare between Delhi and Tashkent.

The incidental expenditure came to only Rs. 3,400.

SHRI DEOKINANDAN NARAYAN: This Statement shows that representatives from only some few States we e included. May I know why other Statej were not represented on this delegation?

DR. P. S. DESHMUKH: Sir, this was an invitation from the Minister of the U.S.S.R. specifically in the names of those individuals who had been sent there.

SHRI DEOKINANDAN NARAYAN: May I know the occasion and the purpose of this delegation visiting Rus Ja? DR. P. S. DE3HMUKH: It was, as I said previously, a friendly invitation from the Minister who had visited India and since he happened to visit these State<sub>3</sub> and met the<sup>^</sup> Ministers, he invited them.

SHRI DEOKINANDAN NARAYAN: May I know, Sir, if the delegation has submitted any report and, if not, when that report will be submitted and also whether it would include any recommendation to be adopted by the Government of India for the development of agiiculture?

DR. P. S. DESHMUKH: Sir, we have decided now to submit a report; it will take a few weeks more.

SHRI SONUSING DHANSING PATIL: What is the gain of this delegation to the agricultural production of this country? Any benefit derived from this delegation?

DR. P. S. DESHMUKH: I do not think, Sir, any delegation can claim that it has increased agricultural production directly. There are incidental and other indirect advantages After all, Si', I am sure nobody in the House will gainsay the fact that visiting and seeing other countries does add to one's knowledge and also brings in more and more information.
