THE DEPUTY MINISTER OF SCIENTIFIC RESEARCH AND CULTURAL AFFAIRS (DR. MONO MOHAN DAS): (a) Yes, Sir.

(b) The matter is under examination.

LIMITATION PLACED BY RESERVE BANK ON ADVANCES TO SCHEDULED BANKS

- *559. SHRI P. RAMAMURTI: Will the Minister of Finance be pleased to state:
- (a) whether the Reserve Bank's directive on scheduled bank_s limiting the advances on deposits with the Reserve Bank has in any way affected the money market in the country; and
- (b) if so, how far and in which way?

THE DEPUTY MINISTER OF FINANCE (SHRIMATI TARKESHWARI SINHA): (a) and (b). It is not practicable to determine in a precise manner the impact of the Reserve Bank's directive on the money market. There has, however, been a noticeable decline in the scheduled banks' borrowings from the Reserve Bank and it is expected that this will exercise a restraining influence on the pressure of monetary demand.

SUPPLY OF COAL TO STEEL PLANTS

*560. SHRI M. BASAVAPUN-NAIAH: SHRI JUGAL KISHORE:

Will the Minister of Steel, Mines and Fuel be pleased to state:

- (a) whether there was serious shortage of coal supplies to the Steel Plants in the months of July, August and September, 1960;
- (b) if so, whether the production of steel was affected considerably due to the short supply of coal; and
- (c) what steps Government have taken to remedy the situation?

THE MINISTER OF STEEL, MINES AND FUEL (SARDAR SWARAN SINGH):
(a) to (c). I lay a statement on the Table of the House.

STATEMENT

Some shortage of coal was felt during the months of May and June, 1960 but I am glad to inform the House that as a result of various steps taken by Government the more important of which were (i) allotment of necessary wagons for the movement of coal and raw materials for the steel industry (ii) seven-day loading and unloading (iii) ten-day programme of allotment by the Coal Controller (iv) reinforcement of pool of wagons by bringing back into service aged wagons after reconditioning, the supplies of coal have been steadily improving since then. It has been agreed that the necessary railway transport for the movement of raw materials to all the steel plants will be provided. Accordingly, the third coke oven battery in Bhilai and the second coke oven battery in Durgapur were lighted on the 12th October, 1960 and the corresponding blast furnaces will be commissioned towards the end of December, 1960.

In Rourkela the main plate mill and the pipe plant are in operation but the continuous strip mill will go into production only early in 1961. Experience in other countries shows that it takes longer to pick up production on such a mill than in ordinary sheet mills. Because of this, it is proposed to determine the date of commissioning of the third blast furnace hereafter watching for some weeks the pace at which the rolling programme gathers momentum. However, as the furnance is ready and as no difficulty is foreseen in maintaining supplies of raw materials, it can be commissioned whenever required.

REFUSAL OF AID TO FOUR NEWLY ESTABLISHED UNIVERSITIES IN BIHAR BY U.G.C.

*561. Shri P. C. MITRA: Will the Minister of Education be pleased to state whether the University Grants

Commission has refused to grant aid to four new universities that have been established in the State of Bihar this year and if so, what are the reasons therefor?

THE MINISTER OF EDUCATION (DR. K. L. SHRIMALI) A statement giving the requisite information is laid on the Table of the Sabha.

STATEMENT

A temporary embargo not to pay grants to the universities and colleges in Bihar in respect of new schemes was placed by the Chairman, University Grants Commission, on the 6th August, 1960. This was done pending some enquiries made from the universities in Bihar as it was, inter alia, observed (a) that the recent amendment of the Bihar Universities Act raised very important issues concerning the autonomy of the universities, (b) that the Bihar Government had no regular grant-in-aid code rules and could declare colleges as "deficit colleges" at its discretion and (c) a delegation of the Patna University Teachers had met the Chairman and made certain important representations calling for elucidation and consideration. At the meeting of the UGC. held on the 9th September, 1960, the Commission, inter alia, indicated certain amendments to be made to the Bihar Univers ties Act of 1960 and desired that a note regarding the same be sent to the Union Minister for Education for discussion with the Bihar Government. The matter was accordingly discussed by the Union Minister of Education with the Chief Min ster, Bihar. a result of these discussions, much of the misunderstanding was removed and the aforesaid embargo on payment of grants was accordingly lifted by the Chairman towards the end of November, 1960.

DISCHARGE OF CLASS IV EMPLOYEES OF ARMY EDUCATION CORPS CENTRE AND SCHOOL AT PACHMARHI

*562 SHRI NIRANJAN SINGH: Will the Minister of Defence be pleased to state:

- (a) whether it is a fact that 63 class IV employees of Army Education Corps Centre and School at Pachmarhi have been discharged without being given any ground of their discharge,
- (b) if so, since when their services have been terminated,
- (c) whether Government have received any appeal from the Suraksha Karmachari Sangh, Pachmarhi for their re-instatement; and
- (d) if so, what action has been taken by Government on their appeal?

THE DEPUTY MINISTER OF DEFENCE (SHRI K. RAGHURAMAIAH):
(a) and (b) Yes, Sr. 63 temporary non-combatants (unenrolled) who were employed in this Centre and School were discharged on 25-7-1960, as they were surplus to requirements on expiry of a minth's notice in accordance with their terms of employment, and as they refused alternative employment offered.

- (c) Yes.
- (d) Thirty-five of the sixty-three employees have been re-employed, on the re-opening of this Centre and School.
