DETECTION OF UNDESIRABLE LITERATURE UNDER THE SEA CUSTOMS ACT

332. SHRI B. N. BHARGAVA: Will the Minister of FINANCE be pleased to state:

(a) the number of cases detected during the last three years of undesirable literature having been brought into India under Section 19 of the Sea Customs Act; and

(b) the action taken by Government in the cases?

THE MINISTER OF FINANCE (SHRI MORARJI R. DESAI): (a) 1,521 cases during the years 1958, 1959 and 1960 (up to November 1960).

(b) In 1225 cases, the goods were confiscated absolutely. Out of these, in two cases personal penalties were also imposed on the addressees. In one case the goods were released on payment of fine and after destruction of the objectionable pages. In 3 cases, tho goods were allowed to be re-shipped with or without fine. The remaining 292 cases are still under adjudication.
