Siliguri has been made abandoning the old one; and

(c) how this line as newly adopted improves the position and whether it shortens the journey?

THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) Construction of a new broad gauge line from Khejuriaghat to Malda is nearing completion. Its further extension up to Siliguri is likely to be completed some time next year, depending upon receipt of Permanent Way materials.

THE MINISTER OF TRANSPORT AND COMMUNICATIONS (DR. P. SUBBARAYAN): (a) Express Delivery letters are despatched from Hansi in Punjab on Post Office holidays, but not on Sundays.

(b) There is no proposal for despatch of E.D. letters on Sundays. All post offices, with the exception of Night Post Offices and Mobile Post Offices, are completely closed on Sundays and, there is no clearance or despatch of mails on such days. Only late fee articles posted at R.M.S. offices and sections, and at Telegraphs offices at certa'n selected places are accepted and despatched on Sundays. E.D. letters are given special treatment at offices of destination and not at offices of posting.

There have n?t been any reports of black-marketing of this drug from any other State.

- (b) As supplies of this drug made by other firms are available at normal prices, no specific action to deal with the rise in price of 'Nivaqu'n' was >re-sumably taken by State Governments.
