CENSOR OF INDIAN AND IMPORTED FILMS

370. DR. SHRIMATI SEETA PARNAND: Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) the number of imported films and films produced in India during the year 1958-59 and 1959-60;

(b) the number of films refused certificates of public exhibition during the same period;

(c) the number of appeals received by Government and the number of Alms passed as a result of appeals; and

(d) the number of cases in which the producers of imported and Indian films have gone to the court against the decisions of the Central Board of Film Censors?

THE MINISTER OF INFORMATION AND BROADCASTING (DR. B. V. KESKAR): (a) There is no control on the production of films in India. Statistics relating to imports of films are maintained in footage and not in numbers. It is, therefore, not possible to furnish the precise information about the number of films produced in India or imported in any particular year. However, the number of films produced in India/imported and certified for public exhibition by the Board of Film Censors, under the Cinematograph Act 1952, is given below:—
