THE MINISTER OF COMMERCE (SHRI N. KANUNGO): (a) and Government has, under the Essential Commodities Act, fixed prices for the following: -

(i) Rice and Paddy, (ii) Wheat and Wheat Products, (iii) Coal and Coke, (iv) Iron and Steel, (v) Raw-cotton, (vi) Fertilizers, and (vii) Copper.

I regret all the details about the dates of relevant notifications are not very readily available. The orders by and large are already effective.

DANDAKARANYA DEVELOPMENT AUTHORITY

THE MINISTER OF REHABILITA-MINORITY **AFFAIRS** (SHRI MEHR CHAND KHANNA): (a) There is no change in the powers of the newly reconstituted Dandakaranya Development Authority, but with regard to its functions, the Authority has been given a measure of autonomy and is to prepare a general five year plan and a more specific plan for the current financial year. It will prepare its own budget with the approval of the Ministry of Rehabilitation, will be entitled to make minor adjustments within the major allocations.

(b) In all the organs of the United Nations other than the International Court of Justice, the official languages are Chinese, French, English, Russian and Spanish. The official languages of the International Court of Justice are French and English. The working languages of most of the UN bodies are English and French; however in the General Assembly and the Economic and Social Council, Spanish is also a working language.]
