- (a) whether it is a fact that heads of Hindi Sections have been appointed at the Headquarters of each Zonal Railway;
- (b) if so, what is their number and pay scale and since when they were appointed;and

(c) what special duties have been assigned to them?]

- (स) ब्राठ; प्रत्येक क्षेत्रीय रेलवे में एक एक। इनका निर्धारित वेतन-मान ३६०-२०-४०० रुपये ग्रीर अधिकृत वेतन-मान ४५०--२४--४७५ रुपये है।
- (ग) हेड ग्राफ हिन्दी सेक्शन को रेलवे के प्रधान कार्यालय के केन्द्रीय हिन्दी यूनिट की देख-भाल का काम सौंपा गया है। इन यूनिटों के जिम्मे हिन्दी पत्रों का अंग्रेजी में सही अनुवाद करने और अंग्रेजी से हिन्दी में उनका उत्तर तैयार करने के साथ-साथ सभी महत्वपूर्ण प्रधिसूचनाओं, शासकीय श्रादेशों, परिपत्रों, पुस्तिकाओं और हा नीय रेन नियमों और विनियमों के हिन्दी अनुवाद का काम सौंपा गया है।

t[THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) Yes, except on the Southern Railway where the selected candidate is expected to join by the middle of September 1960.

- (b) Eight; one on each zonal Railway. The prescribed scale of pay is Rs. 360—20—500 and the authorised scale is Rs. 450—25—575.
- (c) The Heads of Hindi Sections have been assigned duties of overall supervision of the Central Hindi Units at the Railway Headquarters. These units are responsible for the correct translation of Hindi communications into English and their replies from English to Hindi, as also for the translation into Hindi of all important notifications, administrative instructions, circulars, booklets and local railway rules and regulations.]

REVISED TRUNK TELEPHONE RATES

- 504. SHRI DAHYABHA'I V. PATEL: Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state:
- (a) what is the estimated increase in revenue as a result of the revision in rates of trunk telephone calls; and
- (b) how th's revision of rate has affected trunk telephone traffic?

THE MINISTER OF TRANSPORT AND COMMUNICATIONS (DR. P. SUBBARAYAN): (a) There has been no revision in the trunk Call rate structure. Only the extent of the concession available and the periods during which it is applied have been modified. No appreciable change in revenue is anticipated because of the change in the extent of the concession.

(b) Prior to revision of concessional tariffs and periods heavy peaks of traffic and severe congestion used to occur \mathbf{i}_n the concessional periods. Consequently there were heavy delays and large number of calls were ineffective. The result of the revised concessional tariffs and periods has been to even out the pattern of traffic and reduce the ineffective percen-tag of trunk calls handled in the concessional periods. The overall effect is that traffic is being disposed of much more quickly and efficiently.

NATIONAL HIGHWAYS FROM DELHI TO BOMBAY, DELHI TO AHMEDABAD AND BOMBAY TO AHMEDABAD

- 505. SHRI DAHYABHAI V. PATEL: Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state:
- (a) whether Government propose to provide a double carriageway with a hed^- or space in between on the National Highways from (i) Delhi to Bombay; (ii) Delhi to Ahmedabad; and (iii) Bombay to Ahmedabad to make them safer in view of the growing traffic and, if so, when it is proposed to do so; and
- (b) who puts up road signs, direction boards and mile-stones along these National Highways and why there is no uniformity about the size, colour, markings or language in use on these signs and boards?

THF. MINISTER OF STATE IN THK MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI RAJ BAHADUR); (a) No Sir; such double carriageway can be justified only by large Volumes of traffic, which do not obtain all along on these National Highways.'

(b) The State Governments, through whose agency the National Highways are contructed and maintained, put the signs, etc. In some cases the old sign-posts which were fixed before the roads were declared as National Highways are still standing and, therefore, there is no uniformity. These old signs are being gradually replaced by standard signs, according to those prescribed i_n the Motor Vehicle Act.

As regards milestones, although a Standard design was prescribed, it was not enforced because of the question of changing to the metric system and fixing kilometre stones. A standard design for kilometre stone has been finalised and kilometre stones will be installed progressively on. roads.
