THE DEPUTY MINISTER OF RAIL-WAYS (SHRI S. V. RAMASWAMY): (a) Yes

- (b) No; though on account of the limited rolling stock and the transhipment capacity on the narrow gauge section Irom Muri to Ranchi and receipt of heavy traffic in construction materials, occasional delays have taken place. During the months of April, May and June, 1960 the average time taken both for wagon loads and "smalls" was less than one month.
- (c) In order ito reduce the transit time between Calcutta and Ranchi, traffic to Ranchi is now being cleared by the all broad gauge route by moving wagons by material Wains from Muri to Ranchi.

The approved expenditure on these schemes is Rs. 80,000 in 1958-59 and Rs. 1,31,000 in 1959-60.

(b) The Central uovernment nave no machinery for directly ensuring the proper utilisation of the financial assistance given by them but subsidies are adjusted by the Accountant General only after verification of the expenditure incurred.
