NEW TUBERCULOSIS MEDICINE

475. SHRI PURNA CHANDRA SHARMA: Will the Minister of HEALTH be pleased to state:

(a) whether it is a fact that some medicine for the cure of tuberculosis has recently been discovered by the Government of India as reported in the Conference of the Tuberculosis Experts held in Sydney (Australia) under the auspices of the World Health Organisation;

(b) if so, what are the details thereof; and

(c) the number of tuberculosis patients (hospital-wise) on whom the medicine was tried and with what results?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR): (a) No such medicine was mentioned at the Tuberculosis Seminar held at Sydney.

(b) and (c) Do not arise.

to improve them?

प्रकार से कार्य नहीं कर रही थीं। उनके सुधार के लिये निम्नलिखित प्रयत्न किये गये हैं :—

- (१) सबसे ३८ समितियाँ पुनरुज्जीवित की जा चुकी हैं।
- (२) ११२ समितियों को १-७-५९ से ३०-६-६० तक परिसमापन आदेश के अन्तर्गत लाया गया है।
- (३) २८ समितियों के कार्यों की जांच सहकारी समिति अधिनियम की धारा ४३ के अन्तर्गत की जा रही है। जांच के परिणाम संबंधित समितियों को सूचित किये जायेंगे, जो या तो बृत्तियों को दूर करके अपने कार्य को पुनः चलायेंगी अथवा उन्हें बन्द करना होगा।
- (४) ७७ समितियों को, जो प्रशासन के सहकारिता विभाग के प्रयत्नों के बावजूद भी कार्य आरम्भ न कर सकीं, 'कारण बताओ' नोटिस भेजे गये हैं।
- (५) शेष समितियों के कार्यों को पुनः आरम्भ कराने के लिये प्रयत्न किये जा रहे हैं।

††THE PARLIAMENTARY SECRETARY TO THE MINISTER OF COMMUNITY DEVELOPMENT AND COOPERATION (SHRI S. D. MISRA): (a) and (b) As on 30th June, 1959, there were 693 societies which were either defunct or were not functioning properly. The following efforts have been made to improve their working:—

- (i) 38 societies have since been revived.
- (ii) 112 societies have been brought under orders of liquidation during the period 1-7-59 to 30-6-60.

(iii) The affairs of 28 societies are being inquired into under Sect on 43 of the Cooperative Societies Act. After the inquiry, the results will be communicated to the societies concerned which will either revive their working after removing the defects or will have to be wound up.

(iv) Show cause notices have been issued to 77 societies which could not start functioning in spite of the efforts put in by the Co-operation Department of the Administration.

(v) Efforts are being made to revive the working of the remaining societies.]
