**PROPOSAL FROM POLAND FOR BUILDING SHIPS FOR INDIA**

**\*724. SHRI BAIRAGI DWIBEDY:** Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state whether Government have received any proposal from Poland for building ships for India in the shipyards of that country?

**THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI RAJ BAHADUR):** Yes, Sir. The offer has been communicated to the Indian shipping companies who have as yet shown no interest.

**DISCONNECTION ON TELEPHONE CONNECTIONS AT SISGANJ GURDWARA**

**\*725. SHRI BHUPESH GUPTA:** Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state:

(a) the reasons why the telephone connections at the Sisganj Gurdwara in Delhi were recently disconnected; and

(b) whether this was done at the instance of the Delhi Administration?

**THE MINISTER OF TRANSPORT AND COMMUNICATIONS (DR. P. SUBBARAYAN):** (a) and (b). The telephone was disconnected in pursuance of an order under Section 5(1)(b) of the Indian Telegraph Act, 1885 passed by the Chief Commissioner Delhi.

**RELEASE OF LAND TO THE HOUSE BUILDING CO-OPERATIVE SOCIETIES IN DELHI**

**\*726. SHRI R. P. N. SINHA:** Will the Minister of HEALTH be pleased to refer to the answer given to Starred Question No. 353 in the Rajya Sabha on the 22nd August, 1960 and state whether the release order for 34,070

acres of land to House Building Co-operative Societies was issued after consultation with the Delhi Development Advisory Council; and if not, what are the reasons therefor?

**THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR):** No, Sir. The Delhi Development Council was not concerned with the matter.

**ELECTRIFICATION OF RAILWAYS UNDER THE SEALDHA DIVISION**

**\*727. DR. A. N. BOSE:** Will the Minister of RAILWAYS be pleased to state:

(a) what is the time schedule for the electrification of the railways under the Sealdha Division; and

(b) whether the doubling of the railway track between Dum Dum Junction and Barasat in the Sealdha-Bongaon line of the Sealdha Division is under consideration?

**THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN):**

(a) In Sealdha Division, electrically operated suburban services are likely to be introduced in stages between 1962-63 and 1963-64, provided the replacement of the existing aerial telecomm. circuits underground cables by the Post and Telegraphs Department and power supply arrangements by the West Bengal State Electricity Board are in time.

(b) Not at present.
