- (a) whether Government have Garden Reach taken over the Work shops (Private) Limited from the Peninsular and Oriental Company 'Group in Calcutta;
- (b) if so, what are the terms on ■which the establishments have been taken over; and
- (c) whether any change in the position of labour employed in the -workshops is contemplated?

THE MINISTER OF DEFENCE (SHRI "V. K. KRISHNA MENON): (a) Yes, Sir. This workshop and Docks have been acquired by Government.

- (b) While Government would have no objection in disclosing the terms •of the acquisition, Government considers it necessary to obtain the con-sent of the vendors to such publication as the transaction is not free from certain obligations which are •outstanding.

ARMED FORCES PERSONNEL DEPLOYED FOR WORK DURING STRIKE

- (a) whether it is a fact that Armed Forces personnel were deployed for work in connection with the recent strike of the Central Government ■employees;

THE MINISTER OF DEFENCE (SHRI V. K. KRISHNA MENON): (a) and (b) Armed Forces personnel assisted civil authorities in the maintenance of vital services in the Railways, Posts and Telegraphs, Civil Aviation and Indian Meteorological Departments, in connection with the strike by a section of the Central Government employees in July, 1960. The tasks assigned to Armed Forces personnel included partial manning of telephone exchanges, maintenance of trunk lines and wireless communications, handling telegrams, operation of some railway yards and railway workshops, maintenance of navigational and communication services of Civil Aviation at important aerodromes, maintenance and operation of essential meteorological wireless and teleprinter channels etc. This assistance was extended under the provisions of the Armed Forces (Emergency Duties) Act, 1947.
