the country do not conform to the proper wattage and the consumers have to pay higher prices for the said articles;

(b) whether it is a fact that the manufacturers deliberately dump on their authorised dealers electric goods which are less in demand and fetch them comparatively higher profits;

(c) whether it is a fact that the lamp manufacturers have appointed "preferential dealers" in big towns and release supplies to them on quota basis; and

(d) whether it is a fact that these dealers are forced, to avoid termination of their dealership, to accept manufacturers' allotment of full quota of high wattage lamps, tube light accessories and fittings, flood lights and even ceiling fans though most of these articles find no market in their areas?

THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH): (a) There is some shortage of low wattage lamps, particularly  $a_S$  one manufacturing unit is closed. The position is, however, improving.

(b) to (d). The main manufacturers of electric lamps in the country sell their products through the sales organisations of their shareholders. Some of these sales organisations are also distributors of other electrical stores and accessories such as electric fittings and fans and may be selling lamps along with fittings. We have no information about their sales and distribution policies.
