THE MINISTER OF DEFENCE (SHRI V. K. KRISHNA MENON): (a) I have *een a report purporting to imply that I had said that our defences were inadequate. A report which appeared in the Indian Press purported to relay what it said appeared in the 'Times of London' and printed the allegedly relevant part of the report within quotation marks which would convey Ihe impression that it was my words that were being quoted. I have since seen the report of the 'Times of London' which does not purport to quote me, but has the said words as part of their write-up, as their correspondent's report of a speech it said I had made. I did speak in Srinagar at more than one gathering, but none from a script. I have no recollection whether I used the words "inadequate" or not, but even as reported, the reference to inadequacy is coupled with there existing "strong defences". At this distance of time I do not wish to assert that the words "inadequate" may not have been used, but if it was, it would be in a context of urging our people to be vigilant. The report in the Indian Press referred to convey a wrong impression as it purports to quote me.

SHRI V. K. KRISHNA MENON: It would be a rash Government that would say that a country's defences are totally adequate. There is however, no suggestion of the inadequacy of our defences

THE DEPUTY MINISTER OF FIN ANCE (SHRIMATI TARKESHWARI SINHA) Government have noted the view of the Estimates Committee in ninety-second report that the their the strength of increase in Joint Secretaries, Deputy Secretaries and Secretaries is unduly Under high. Being deeply conscious of the need for Government economy, have taken steps to ensure economy in all sectors of public expenditure. Even before the ninety-second report of the Esti presented. Committee mates was Government had imposed, in January, 1960, a ban for one year on recruit ment to all posts not connected with the Plan or required for security pur poses.

Even with regard to posts connected with the Plan, it was provided that new items of work should, as far as possible, be handled by suitable redistribution of work among the existing staff and not by fresh recruitment.

The Central Economy Board set up some time ago is also keeping a close watch on ways and means of ensuring economy. There is further an Economy Committee in each Ministry for the same purpose. The Special Reorganisations Unit of the Ministry of Finance is continuing work studies in and examination of the organisation of the various Ministries with a view to ensuring the most economical use of staff.

SHRIMATI TARKESHWARI SINHA: Sir, in the beginning of the Second Five Year Plan there were some promotions given. Therefore, the number of Secretaries, Deputy Secretaries and Under Secretaries increased. But from January 1960 the Home Ministry has made it quite clear that no further appointment can be made, and we also reduced our expenditure to the tune of about Rs. 1,50,00,000 per annum by ensuring economy in different waysdifferent personnel and different units of the Government-

DR. RAGHUBIR SINH: May I know, Sir, if any restrictions have also been imposed in respect of promotions?

SHRIMATI TARKESHWARI SINHA: Sir, it all depends upon the nature of the work to be done, and Government is trying to do its best not to encourage promotions unless and until they are urgently needed for that particular type of work.

DR. RAGHUBIR SINH: May I know if any steps are taken to see that no fresh promotions are made by creating new posts?

SHRIMATI TARKESHWARI SINHA: Well. Sir, no hard and fast rules can be laid down in this connection, but efforts are made to see that economy is maintained.
