SUSPENSION OF GOVERNMENT EMPLOYEES IN MAHARASHTRA ON ACCOUNT OF STRIKE

*229. SHRI S. K. LIMAYE: Will the Minister of HOME AFFAIRS be pleased to state the total number of Central Government employees in the State of Maharashtra who have been (i) suspended; (ii) discharged or dismissed in connection with the Central Government employees' recent strike?

THE MINISTER OF HOME AFFAIRS (SHRI GOVIND BALLABH PANT): The jurisdiction of the different Zones and Circles of the Central Government Departments are not necessarily coterminus with those of States. Information regarding Central Government employees suspended or discharged or dismissed in connection with the recent strike "is being collected Departmentwise and not Statewise. The process of scrutiny and review is still continuing and full information will be given later.
