

**DEFENCE PERSONNEL'S ASSISTANCE IN CONDUCTING ENQUIRY INTO EXPLOSIONS IN TEXMACO, BELGHURIA**

\*218. **SHRI K. L. NARASIMHAM:**  
**SHRI BHUPESH GUPTA:**

Will the Minister of DEFENCE be pleased to state:

(a) whether any assistance of the Defence personnel was sought for conducting enquiry into certain explosions in TEXMACO, Belghuria, West Bengal;

(b) if so, the reasons for which this assistance was sought;

(c) whether he has received any report of the enquiry; and

(d) if so, what is the nature of the report?

**THE MINISTER OF DEFENCE (SHRI V. K. KRISHNA MENON):** (a) Yes, Sir.

(b) The Factory management found certain suspicious looking items, in their furnaces. One of these items was identified as service ammunition by the Inspector of Explosives, East Circle. He, therefore, sought the assistance of the military authorities to examine the furnace as well as its remaining content.

(c) Yes, Sir.

(d) An enquiry to determine the cause of explosion is being conducted by the Sub Divisional Magistrate, Barrackpore, under the orders of the District Magistrate, 24-Paraganas. The matter, thus, being *sub judice*, it will not be proper to disclose the nature of the report submitted by the Ammunition Inspecting Officer (Army) at this stage.

**CALLING OF TROOPS IN GAUHATI AND SHILLONG**

\*225. **SHRI P. RAMAMURTI:** Will the Minister of DEFENCE be pleased to state:

(a) whether it is a fact that the troops were called out in Gauhati and Shillong in aid of civil authority on the 4th July, 1960; and

(b) what were the specific duties assigned to them?

**THE MINISTER OF DEFENCE (SHRI V. K. KRISHNA MENON):** (a) Army authorities were asked by the State Government to assist in the maintenance of law and order at Gauhati with effect from the 4th July 1960 and at Shillong on the 6th July 1960, in accordance with procedures and practice.

(b) At Gauhati, troops patrolled the disturbed areas, established picquets at important places, conducted a flag march and cordoned off certain villages to help the police in carrying out searches. At Shillong, the troops patrolled the disturbed areas and established picquets.
