STATEMENT

On receipt of a message from the State authorities on 8th August, 1960, the Oil and Natural Gas Commission were asked to investigate the alleged oil show on Jamuna Bank near Balk-eswar Temple about five miles from Agra. Two Technical Officers of the Commission visited the site and collected samples of sand and oil. The results of the examination of these samples and the geological associations of the oil show are such that the occurrence of natural hydrocarbons in the area appears to be improbable. The matter will be investigated further by the Oil and Natural Gas Commission after the rains.

**SMUGGLING OF GOLD BY SHIP
"BUT*EVERETT"**

- (a) whether it is a fact that the Calcutta Customs authorities have seized 8,320 tolas of gold from the ship "Ruth Everett";
- (b) whether it is a fact that some gold was seized from persons who were on board the ship; and

(c) what action Government have taken against the culprits?

THE DEPUTY MINISTER OF FINANCE (SHRI B. R. BHAGAT): (a) and (b) Up to the 16th August, 1960, 29,909 tolas of gold had been seized from the ship M. V. "Ruth Everett" or from the crew of the ship. Details of the seizures are shown in the statement which is placed on the Table of the Sabha. [See Appendix XXX, Annexure No. 28.]

(c) The case is under investigation by the Calcutta Customs authorities. Some members of the crew have been arrested. Action against the vessel under section 167 (12A) of the Sea Customs Act is under consideration.
