- (d) Target of production of clotn for the Second Five Year Plan period has been placed at 5100 million yards and the following steps have been taken for achieving the target figure:
  - (i) Provision for installation of 3,000 automatic looms " has been made in the Cotton Textiles Export Incentive Scheme with a view to promote exports.
  - (ii) 9,000 automatic looms would be allowed to be installed for replacement purposes; out of which licences have already been given for 7,500 automatic looms.
  - (iii) Some of the mills have started working in the 3rd sh'ft recently. Out of 38 closed mills at the beginning of this year, 7 mills have already reopened. Attempts are being made to reopen more closed mills.
  - (iv) Adequate loans are being given through various Government Agencies such as N. I. D. C, I PC, etc foi rehabilitation, modernisation; expansion of the existing plant.

SHRI MAHESWAR NAIK: From thb statement, I find that the reply to part (a) of the question is "No." But as far as I can find from the figures that have been given in the statement,

the production of cloth In 1956-57 is 5,420 million yards; in 1957-58 it is 5,179 million yards; in 1958-59, it is 4,920 million yards and in 1959-60, it is 4,928 million yards.

MR. CHAIRMAN: He knows all that.

SHRI MAHESWAR NAIK: May I know how these two statements are reconciled?

SHRI N. KANUNGO: The fact is that, if the figures for 1959-60 are compared with those for 1958-59, it will show an increase. The figures for 1956-57 and 1957-58 are not realistic in the sense that because of certain special factors, there was a distorted range of production resulting in large gluts.

SHRI MAHESWAR NAIK: What are those special factors which were responsible for the decline in production in these years?

SHRI N. KANUNGO: It is not a question of any decline. In 1957-58 and 1956-57, there was an unusual production which led to a large accumulation of stocks due to a certain lacuna in the excise duty structure which tempted people to go in for production of cloth which was not saleable.

SHRI MAHESWAR NAIK: May i know whether the Government is expecting to complete the target oi production set out in the Plan?

SHRI N. KANUNGO: Yes, Sir.

# DEVELOPMENT OF ANCILLARY INDUSTRIES

\*439. SHRI M. S. GURUPADA-SWAMY: Will the Minister of COM-MERCE AND INDUSTRY be pleased to state whether any positive steps have been taken by Government for thu development of ancillary industries and if so, what are those steps?

THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH): A statement is laid on the Table of the House..

### STATEMENT

Yes, Sir. The following steps have been taken for development of ancillary industries:

- (i) Development of a number of small units around large units to serve as perpetual feeders of components and parts to large manufacturing units in the public as wel] as private sectors. This is achieved by prior agreement of the large uni s to enter into long term contracts with ancillaries assuring them a minimum annual offtake at predetermined prices. So far, negotiations have been completed with 9 public sector projects and 14 firms in the private sector:
- (ii) Supply of machinery on more liberal terms to ancillary units under the Hire Purchase Scheme of the National Small Industries Corporation.
- (iii) Relaxation of capital investment of units manufacturing ancillaries. It has been decided that certain facilities at present available to small scale industries should be extended to small scale units engaged in

the production of ancillaries ind components required by large industries, even if their capital investment is upto Rs. 10-0 lakhs. These facilities will be (a) technical assistance through the Small Industries Service Institutes, (b) Supply of machinery under the hire-purchase scheme and (c) allotment of factories in Industrial Estates. To begin with, the relaxation in capital ceiling shall apply to industrial units manufacturing ancillaries and components for certain specified industries.

(iv) A survey in each State is being undertaken to find out the extent of purchase being made by large scale units from small scale units and how to give greater impetus to thiy trend of ancillary development.

SHRI M. S. GURUPADASWAMY: Sir, I find from the statement that negotiations have been completed with nine public sector projects and fourteen firms in the private sector. May I know why up to now no ancillary industry has been started and what accounts for this delay?

SHRI MANUBHAI SHAH: No, Sir. The Hindustan Machine Tools lias already started this and o.her public sector projects will also take it up.
