SHRI B. N. BHARGAVA: May I know, Sir. why the U.P. Government have not been able to introduce this scheme in rural areas?

SHRI S. D. MISRA: It is probably due to financial difficulty involved there.

SHRI B. N. BHARGAVA: Were the financial implications of the scheme pointed out to the State Government in this connection in any instructions issued by the Central Government?

SHRI S. D. MISRA: Yes Sir.

SHRI N. M. LINGAM: May I know. Sir, if the Government have thought it necessary to commend the example of Madras where the scheme of providing midday meals for children is financed entirely by the population of the State?

SHRI B. S. MURTHY: Madras is doing really wonderful work as far as this scheme is concerned.

MR. CHAIRMAN: He is not fishing for a compliment.

SHRI B. S. MURTHY: But I do not know whether it is possible for every State to accept that arrangement.

SHRI N. M. LINGAM: Not even in Andhra?

SHRIMATI SAVITRY DEVI NIGAM: Keeping in view the limited resources of States like Uttar Pradesh, is the Government thinking of subsidising or giving additional grant for such schemes like midday meals?

SHRI B. S. MURTHY: As far as the Harijans are concerned, the Centre is bearing 50 per cent, contribution. As

far as the other children of poor sections are concerned, it is more or less on a voluntary basis like the Madras scheme.
