

(b) Besides imparting training in the trade for a period of 18 months in the Industrial Training Institutes, as in the case of craftsmen training, special instructions are imparted in business management, principles of co-operation, vocational counselling etc. The trainees will also be given practical training, preferably in small scale industries where they will have opportunities for learning not only the techniques of the trade but also of entrepreneurship.

Stipends will be awarded to 50 per cent, of trainees at the rate of Rs. 251-per month.
