## STATEMENT RE INDO-PAKISTAN CONFERENCE ON EASTERN BOR-DER PROBLEMS

THE DEPUTY MINISTER OF EX-TERNAL AFFAIRS (SHRIMATI LAKSHMI MENON): Sir, the House is aware that the Prime Minister of India met the President of Pakistan at Palam airport on September 1, 1959. During their talks it was agreed that a high level conference at Minister level should be held to discuss the disputes and incidents on the Indo-East Pakistan border with a view to eliminating, as far as possible, the causes of these disputes and devising procedures for expeditious demarcation of boundaries and for dealing promptly with any disputes and incidents that may occur.

This Minister-level conference was held from 15th to 22nd October 1959; discussions were held at Dacca from 18th to 20th October and at Delhi en other days.
