#### STATEMENT

On 6th November, 1959, 1 NS (New Delhi-Sonepat) diesel rail car left New Delhi at 09.18 hours and arrived Subzi-mandi station at 09.23 hours. It was booked to leave Subzimandi at 09.40, but about 200 students of Hindu College, Sonepat, entrained the rail car at Subzimandi with the result that it became overloaded and could not be started. The students refused to vacate the rail car in spite of the intervention of local Police and Magistrate. The matter was referred to Deputy Commissioner, Delhi who arrived at site ai 13.10 hours. He along with the Traffic Inspector of the Railway held discussions with the students and assured them that their case would be referred to the appropriate authorities for suitable action. Thereafter, the students vacated the rail car, which left at 13.40 hours instead of at 9.40 hours i.e. 4 hours late.]
