श्री राभ सहाय : क्या में यह जान सकूंगा कि कितने हरिजन परिवारों को इस स्कीम से लाभ पहंचेगा ?

SHRIMATI VIOLET ALVA: As to the number of people, it is not easy to give. As regards the different States, most of the State Governments are working on the principles and acting on them, namely in respect of giving house sites and other assistance.

SHRI B. K. P. SINHA: Are Government aware that the building of separate colonies and separate hostels for Harijans prevents the integration of Harijans in the rest of society?

SHRIMATI VIOLET ALVA: Government is quite aware of that and it is considering this question.

SHRI B. K. P. SINHA: Why then are Government continuing this practice even now?

SHRIMATI VIOLET ALVA; We are encouraging co-operative societies which would be for all also.

SHRI BHUPESH GUPTA: Has the hon. Minister's attention been drawn to the fact that the performance in this respect so far under the Second Five Year Plan is far below the target set in the Plan?

SHRIMATI VIOLET ALVA: Sir, it varies from State to State. In some States it has been a little below the target. It varies from region to region and from State to State.

CANTONMENT AT JORHAT IN ASSAM

REPORT ON 'DOMESTIC FUELS IN INDIA'

(b) The suggestions *inter alia* include a phased development of coal based energy processing industry, and, to begin with, the setting up of domestic coke plants at a few big cities.

(c) Government will take note of the Council's approach to various aspects while considering proposals for setting up domestic coke plants during the Third Plan period.
