up their own pavilions and exhibits. The three Divisions of the C.P.W.D., viz., (1) The Exhibitions and Decoration, (2) Electrical Division and (3) the Horticultural Division, have undertaken on behalf of the Samaj, on payment basis, the work relating to repairs of roads, painting and distempering of buildings, laying cables and electrifying the exhibition grounds, and the laying of lawns and gardens.

Administrative officers and experts •of the Ministries of the Government of India, the Delhi State, and the Delhi Municipal Corporation, are also serving on the various Committees for assisting the Samaj in organising the Fair.

PURCHASE OF FOODGRAINS FROM U.S.A. TO BUILD TIP BUFFER STOCKS

- '-40. SHRI M. BASAVAPUNNAIAH: Will the Minister of FOOD AND AGRICULTURE be pleased to state:
- (a) whether Government propose to purchase from the United States of America large quantities of foodgrains to build up buffer stocks;
- (b) if so, what is the quantity proposed to be purchased and what will be its value; and
- (c) what are the terms under which the purchases are to be effected?

THE DEPUTY MINISTER OF FOOD AND AGRICULTURE (SHRI A. M. THOMAS): (a) Yes, it is the intention to build up and maintain larger stocks and at present the most convenient and practicable method may be to augment imports from U.S.A.

(b) and (c). The details are under examination.
