SHRIMATI LAKSHMI MENON: That is all given in the original .answer.

श्री पां० ना० राजभोज : क्या यह सच है कि अप-प्रचार के कागज कान्फिडेंशल मार्क करके लंदन स्थित फारेन आफिस को भेज गर्ये थे ?

SHRIMATI LAKSHMI MENON: That is also given in the original answer. All the Missions have denied that they ever received a paper like this.

श्रो जवाहरलाल नेहरू: मानेनीय सदस्य बगैर जवाब सुने उसी बात को दुहराते जाते है तो जवाब कैसे दिया जाये।

श्रो पां० ना० राजभोज : मैं हिन्दो में पूछता हूं। इसलिये जवाब हिन्दी में मिलना चाहिये।

### PAKISTAN PRESIDENT'S MESSAGE SENT THROUGH LT. GENERAL K. M. SHAIKH

\*144. SHRI V. K. DHAGE: Will the PRIME MINISTER be pleased to state:

- (a) whether it is a fact that the Presidem of Pakistan sent a message through Lt. General K. M. Shaikh on «or about the 14th October, 1959; and
  - (b) if so, what?

THE DEPUTY MINISTER OF EX TERNAL AFFAIRS (SHRIMATI LAKSHMI MENON): (a) and (b). The President of Pakistan sent his greet ings to the Indian Prime Minister through Lt. General K. M. Shaikh.

SHRI V. K. DHAGE: May I know, Sir, whether there was any proposal in the greetings that they should meet some time in the near future.

SHRIMATI LAKSHMI MENON; That was just an oral greeting.

SHRI JAWAHARLAL NEHRU: The greeting was an oral one, there was nothing in writing, but as has been stated by me in Parliament and elsewhere, when I met the President himself, he had suggested that on my way back from Tran I might stop over for a little while in a Pakistan airport.

## CENTRAL TRAINING INSTITUTE IN TOY-MAKING

- \*145. SHRI AMOLAKH CHAND: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:
- (a) whether Government's attention has been drawn to a news item published in the *Hindustan Times* of the 19th October, 1959, to the effect that Government have taken a decision to start a central training institute for training personnel in toy-making; if so, what will be the special features of this institute; and
- (b) whether Japan is likely to help the institute with trained teachers?

THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH): (a) and (b). It is proposed to set up a panel to consider development and manufacture of toys and dolls. This Committee would consider such a proposal and make its recommendations.

SHRI AMOLAKH CHAND: May I know when this panel was appointed and also the names of the members of this panel?

SHRI MANUBHAI SHAH: The panel is yet to be appointed. It will consist of about eleven to fifteen members and the names are about to be finalised. Within a month or so, the whole thing will be settled.

## GAS PLANT AT BHOPAL

- \*146. SHRI JUGAL-KISHORE: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:
- (a) whether Government have awarded a contract for the supply,

(b) if so, what is the value of that contract and when it is to be completed?

THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH): (a) Heavy Elec-tricals Ltd., Bhopal have placed an order for a gas plant on M|s. Humphreys & Glasgow Ltd., London through the Associated Electrical Industries, London who are technical consultants to the Project.

(b) The value of the contract is Rs. 16-67 lakhs and it is expected to *he* completed by December, 1960.

SHRI JUGAL KISHORE: May I know, Sir, Whether any Indian firm was contacted for this job?

SHRI MANUBHAI SHAH: No, Sir. This is a question of purchase of technical equipment from the U.K. Naturally, along with the purchase of machinery, we have to hold them responsible for erection as well as commissioning of the plant and, therefore, it has got to be a sort of turn-key job.

THE DEPUTY MINISTER OF LABOUR (SHRI ABID ALI): (a) Yes.

SHRI ABID ALI; No, Sir, not yet.

SHRI BHUPESH GUPTA: May I know, Sir, whether apart from the centres mentioned in the reply, attempts were also made at other centres to bring about a settlement?

SHRI ABID ALI; That is what I have already indicated in the main answer.

MR. CHAIRMAN: You always try to bring about a settlement.

#### NAGA PEOPLE'S CONVENTION

•148. SHRI BHUPESH GUPTA: Will the PRIME MINISTER be pleased to state whether Government have considered the proposals of the Naga People's Convention, held in October and if so, with what results?

THE DEPUTY MINISTER OF EX TERNAL AFFAIRS (SHRIMATI LAKSHMI MENON): The proposals of the Third Naga People's Convention held at Mokokchung in October 1959 have not been formally presented to the Government so far. These will be considered as and when they are received through proper channels.

SHRI BHUPESH GUPTA: May I know, Sir, whether the attention of the Government has been drawn to
