ORAL ANSWERS TO QUESTIONS**WORKING JOURNALISTS OF THE
'HINDUSTHAN STANDARD' DELHI**

*21. SHRI M. P. BHARGAVA: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

(a) whether it is a fact that the Working Journalists of the 'Hindusthan Standard', Delhi, had filed claims with the Delhi Administration in November, 1959 requesting that the paper be classified as Class 'B' in line with its counterpart the 'Hindusthan Standard' of Calcutta;

(b) whether it is a fact that they have demanded payment of arrears according to Class 'B'; and

(c) whether any steps have been taken by Government in the matter, and if so, what?

**STERILITY TESTS OF ANTIBIOTICS AT
PIMPRI FACTORY**

*22. SHRI M. P. BHARGAVA: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:

(a) whether the Quality Control Department of the Hindustan Antibiotics Ltd., Pimpri has again been placed under the control of the Superintendent of Research, and if so, since when; and

(b) how many batches of antibiotics were submitted for sterility tests in the months of January, February and March this year and how many of those were rejected?

THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH): (a) No, Sir.

(b) Out of 261, 358 and 253 batches tested in January, February and March (upto 26th) 59, 57 and 67 batches respectively were rejected.

SHRI M. P. BHARGAVA: May I know, Sir, whether any investigation has been made to find out as to why such a high percentage of rejections has taken place during these three months?

SHRI MANUBHAI SHAH: This is the normal rejection, Sir. After all, this quality control is meant for testing everything very rigidly and whatever is below standard is rejected and it is reprocessed.

SHRI M. P. BHARGAVA: May I know, Sir, whether this rejection has been of this order during the period of penicillin production in that factory?
