SHRI K. MADHAVA MENON: What is the interest that the L.I.C. is charging on loans supplied by the previous Governments to policy-holders?

SHRIMATI TARKESHWARI SINHA: So far as this scheme is concerned, it bag not come into operation. But they will charge 7 per cent, interest with half per cent rebate if the payment is made punctually.

SHRI BHUPESH GUPTA: Since the scheme has been drawn up with a view to easing the housing situation in these towns, may I know, Sir, whether the Government has given any advice or directions to the L.I.C. in the matter so that the scheme becomes possible of implementation?

SHRIMATI TARKESHWARI SINHA: Sir, the L.I.C. Investment Committee and the Corporation itself approved this scheme, and it is for them to implement it.

SHRI BHUPESH GUPTA: May I know, Sir. whether the hon. Minister is aware of whatever little has appealed with regard to this scheme that it has been publicly criticized that many small policy-holders living in these cities would not be in a position to avail of this scheme because of the onerous' terms associated with this scheme?

SHRIMATI TARKESHWARI SINHA: The scheme has not come into operation yet It is yet to be seen whether the public is satisfied or dissatisfied.
