**THE PRIME MINISTER AND MINISTER OF EXTERNAL AFFAIRS (SHRI JAWAHARLAL NEHRU):** (a) and (b). Some 100 Tibetan refugees were camping outside Mori Gate, Delhi. It was believed that they earned their livelihood by taking recourse to begging. It is understood that they have now gone to various places with more congenial climate, such as Simla Hills, Dharamsala and Rawalsar.

#### REFRESHER COURSES AND TRAINING IN PRODUCTIVITY

**33. SHRIMATI SAVITRY DEVI NIGAM:** Will the Minister of COMMERCE AND INDUSTRY be pleased to state the number of business magnates, directors and managers of factories and mills, who were sent for refresher courses and training in Productivity by the Productivity Councils in the years 1958-59 and 1959-60?

**THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH):** A number of training programmes are being organised in the country by the National Productivity Council and Local Productivity Councils. The National Productivity Council also sponsors training abroad in subjects of industrial productivity. These training courses are not meant for Business Magnates or Directors. Out of 57 Trainees sent abroad in 1958-59 and 1959-60, 18 belong to managerial positions in factories. The number of managers who participated in the training programmes organised within the country is not readily available.

AMOUNT SPENT ON THE PROVISION OF AN EXTRA KITCHEN IN THE WESTERN COURT HOSTEL, NEW DELHI

**THE DEPUTY MINISTER OF WORKS, HOUSING AND SUPPLY (SHRI ANIL K. CHANDA):** Sir, in reply

to part (e) to Unstarred Question No. 68, answered on the 18th February, 1960, the amount spent on certain additions and alterations for providing an extra kitchen and room for the Resident Inspectress of the Western Court Hostel, New Delhi, was said to be Rs. 10,532. But the figure of Rs. 10,532 includes Rs. 7,648 on account of the cost of cloak room provided for the use of residents of the Western Court Hostel. The correct amount spent on the provision of a kitchen and a verandah for the Resident Inspectress is, therefore, Rs. 2,884.
