(b) and (c) Import licence to the Andhra State Government for Rs. 2.42 crores has been issued. The State Government is conducting the negotiations with the Japanese suppliers.

**THIRD ANNUAL REPORT OF THE STATE TRADING CORPORATION**

•111. SHRI BABUBHAI CHINAI: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:

(a) by when the State Trading Corporation expects to submit its Annual Report for the year 1958-59;

(b) whether any estimates have so far been made about the trading activities of the Corporation in the year 1958-59, and if so, what is the actual quantum of exports and imports handled, both in terms of quantity and value during that year;

(c) the profit made by the State Trading Corporation separately on each item of import; and

(d) the profit made by the Corporation on each item of export?

THE MINISTER OF COMMERCE (SHRI N. KANUNGO): (a) Annual Report of the State Trading Corporation for the year 1958-59 is proposed to be laid on the Table of the House during the current session.

(b) A statement showing the quantity of imports and exports handled by the State Trading Corporation in the year 1958-59 is laid on the Table of the House. It is not in the business interest of the Corporation to divulge the value of the imports and exports, "in terms of quantity and value."

(c) and (d) It is not in the business interest of the Corporation to give details of the profits made by the Corporation item-wise on its imports and exports.
