**NUMBER OF DOCTORS APPOINTED IN THE
PRIMARY HEALTH CENTRES**

53. SHRI NIRANJAN SINGH: Will the Minister of HEALTH be pleased to state the number of doctors appointed by Government in the Primary Health Centres during the year 1959-60, who have passed the examination in the Integrated System of Medicine?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR) : Primary Health Centres are established and maintained by the State Governments. Information pertaining to the number of doctors qualified in Integrated System of Medicine appointed by State Governments in Primary Health Centres is not available. In the three Centres run by the Government of India in Delhi there are no medical officers with the qualification stated.

**CENTRAL ASSISTANCE TO ORISSA FOR
RURAL ELECTRIFICATION**

54. SHRI MAHESWAR NAIK: Will the Minister of IRRIGATION AND POWER be pleased to state the total amount given as Central assistance to the State of Orissa during the Second Five Year Plan period up to date for rural electrification and the assistance proposed to be given during the rest of the Second Plan period?

THE DEPUTY MINISTER OF IRRIGATION AND POWER (SHRI J. S. L. HATHI) : No amount has so far been given to the Government of Orissa specifically for rural electrification during the Second Five Year Plan. Proposals covering nine schemes costing Rs. 19,59,48.7 during the remaining period of the Plan, are under examination.
