THE DEPUTY MINISTER OF RAILWAYS (SHRI S. V. RAMASWAMY): (a) and (b) At about 4.45 hours on 4th April, 1960, while Engine No. 2001 GA was being moved on the back pit at Agra Loco Shed, it went out of control and dashed against two other engines standing near the dead-end. As a result of the impact one of the stationary engines derailed. The Yard Khalasi Cleaner and a Steam Man working on the derailed engine and the Shunter of Engine No. 2001 GA received injuries. The Yard Khalasi Cleaner, whose injuries were serious, subsequently died in the hospital.

STUDY IN MAHANADI DELTA AREA

STATEMENT

To conduct a detailed study of the flood problem in the Mahanadi delta, the Central Water and Power Commission had requested the Chief Engineer, Orissa, to furnish certain data about the various channels of the Mahanadi river in the deltaic reach. The requisite data are still awaited from the State Chief Engineer. On receipt of the data, the problem will be studied by the Central Water and Power Commission and, if necessary, an expert of a team of experts will be sent to make a detailed on-the-spot study.
