166. SHRI NIRANJAN SINGH: Will the Minister of RAILWAYS be pleased to state:

(a) the number of thefts of Government cash which were committed during the last two years at the Katni railway station on the Central Railway; and

(b) the number of persons who have so far been apprehended in this connection?

THE DEPUTY MINISTER OF RAIL-WAYS (SHRI SHAH NAWAZ KHAN): (a) Only one case of theft of Government cash from Katni station was reported during the last two years.

(b) No one was apprehended.

BRIDGE OVER THE SINDH RIVER ON THE BHIND-BHANDER ROAD IN THE DISTRICT OF BHIND IN MADHYA PRADESH

167. SHRI NIRANJAN SINGH: Will the Minister of TRANSPORT AND COM-MUNICATIONS be pleased to state whether the Government of Madhya Pradesh have sent any proposal to the Government of India for seeking their approval and cooperation for the construction of a bridge over the Sindh river on the Bhind-Bhander road in the District of Bhind; if so, what action has been taken thereon?

THE MINISTER OF STATE IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI RAJ BAHADUR): Yes, Sir. The State Government wanted a grant-in-aid to meet 50% of the cost of construction of the proposed bridge. Due to paucity of funds, it has not been possible

to give any financial assistance in the matter. It has, however, been suggested to the State Government that in case they consider the work in question to be urgent, they might examine the feasibility of financing it from their Central Road Fund Allocations Account in which sufficient free balance exists to meet the cost of this project.

RECLAMATION OF WASTE AND ALKALINE LANDS

168. SHRI MAHESWAR NAIK: Will the Minister of Food and Agriculture be pleased to state:

(a) whether the inexpensive method of reclaiming waste and alkaline lands, discovered by the National Botanical Garden's experimental Farm at Banthra has been tried elsewhere; and if so, with what results; and

(b) if the experiment has been successfully tried, whether any attempt is being made by Government for its universal adoption in the country?

THE MINISTER OF AGRICULTURE (DR. P. S. DESHMUKH): (a) No. The Council has, however, recommended that this method be tried in their schemes operating in Andhra Pradesh and Punjab.

(b) Not yet. Results of the trials are awaited.

Construction of the High School Building at Bilaspur, Madhya Pradesh

169. SHRI DAYALDAS KURRE: Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that Government propose to construct the High School building at Bilaspur, (Madhya Pradesh) at the end of the Second Five Year Plan period; and

(b) what amount has been allotted for the construction of the building? [RAJYA SABHA]

THE DEPUTY MINISTER OF RAIL-WAYS (SHRI SHAH NAWAZ KHAN): (a) The proposal is to extend the High School building at Bilaspur. This work is in progress.

(b) Rs. 40,000, which includes the cost of extension, furniture and equipment.
