t[RAILWAY LINE BETWEEN SATNA AND GOVINDGARH

*351. SHRI GURUDEO: Will the Minister of RAILWAYS be pleased to state the progress so far made about the construction of a new railway line between Satna and Govindgarh (via Rewa) in Madhya Pradesh for which survey was made a few years back?]

रेल उपमंत्री (श्री शाहनवाज खां) : १९५६-५७ में इस लाइन का सिर्फ यातायात सर्वे (Traffic survey) किया गया था जिससे पता लगा कि इस लाइन से बहुत कम आमदनी होगी। इस पर आगे कोई कार्यवाही नहीं की गई है क्योंकि आयोग (Planning Commission) ने दूसरी पंचवर्षीय आयोजना में नयी रेलवे लाइनें बनाने का जो कार्यक्रम मंजूर किया है, उसमें भी यह लाइन शामिल नहीं है।

f[THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN): Only Traffic Survey of this line was done in 1956-57 which indicated very poor prospects of financial return. Further action has been taken as this line did not also find a place in Railways' programme of new constructions approved by the Planning Commission for the Second Five Year Plan period.]

PLANT AT CHACHAI FALLS IN MADHYA PRADESH

*352. SHRI GURUDEO: Will the Minister of IRRIGATION AND POWER be pleased to state:

(a) whether the survey work in connection with the installation of a hydro-electric plant at Chachai Falls in Madhya Pradesh is in progress; and

(b) if the answer to part (a) above be in the negative, whether Government propose to execute this project?]

सिंचाई तथा विद्युत् उपमंत्री (श्री ज० ला० हाथी) : (क) तथा (ख) चचाई विद्युत् विकास योजना के लिये

सर्वेक्षण और अनुसंधान का अनुमान २१ मार्च, १९६० को स्वीकृत हुआ था। आशा है कि सर्वेक्षण शीघ्र ही आरम्भ कर दिया जायेगा और लगभग दो वर्षों की अवधि में पूर्ण हो जायेगा। सर्वेक्षण के पूर्ण हो जाने पर आवश्यक परियोजना प्रतिवेदन तैयार किया जायेगा। इसकी कार्यान्विति का प्रश्न इस के योजना आयोग द्वारा स्वीकृत हो जाने के पश्चात् ही उठेगा।

[THE DEPUTY MINISTER OF IRRIGATION AND POWER (SHRI J. S. L. HATHI): (a) and (b) An estimate for surveys and investigations for Chachai Power Development Scheme was sanctioned on 21st March 1960. Survey is expected to be started shortly and will take about 2 years to be completed. After completion of the survey necessary project report will be prepared. The question of execution will arise only after the project is sanctioned by the Planning Commission.]

THE MINISTER OF TRANSPORT AND COMMUNICATIONS (DR. P. SUBBARAYAN): (a) to (c) The information is being collected by Air India International Corporation from their offices abroad and will be laid on the Table of the Rajya Sabha in due course.

DAM SITE ON RIVER BARAK IN ASSAM

*354. SHRI S. C. DEB: Will the Minister of IRRIGATION AND POWER be pleased to state:

(a) whether any final report has been submitted by the team which was appointed to find out the dam site on river Barak in the District of Cachar in Assam; and

(b) if so, what steps Government propose to take on that report?

THE DEPUTY MINISTER OF IRRIGATION AND POWER (SHRI J. S. L. HATHI): (a) A team of Engineers, representing Central Water and Power Commission and the Government of Assam assisted by a Geologist inspected the Mainadhar dam site on Barak river in January, 1960. They have suggested that an earth dam of a height of 200 to 250 ft, solely in the interest of flood control, might be practicable at the site and investigations might be carried out to establish the suitability of the site for the proposed earth dam.

(b) At the request of the Government of Assam, the Central Water and Power Commission have recently taken up investigations at this site.
