(c) The time taken for repairs depends on the nature of the defect and availability of the necessary stores

Also, alternative arrangements always exist for the supply of cool drinking water to passengers from *matkas*, *gharrahs* etc.

(d) No, Sir.

DISPENSING WITH CATERING CONTRAC-TORS ON RAILWAYS

- 111. SHRI DAHYABHAI V. PATEL: Will the Minister of RAILWAYS be pleased to state:
- (a) since when it has been the policy of the Railways to do away with catering contractors;
- (b) in how many cases contractors have been dispensed with because of introduction of departmental catering (i) at railway stations and (ii) on trains;
- (c) how many of these departmental catering arrangements ar* running satisfactorily; and
- (d) how many of them are working on profit and how many at a loss?

THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) It is not the policy of Railways to do away with all catering contractors.

- (c) The work of departmental catering establishments on the Railways has been generally satisfactory.

NATIONAL PARK IN ORISSA

112. SHRI GHASIRAM SANDIL: Will the Minister of FOOD AND AGRICULTURE be pleased to state the total amount so far spent for the establishment of the National Park in the District of Mayurbhanj in Orissa?

THE DEPUTY MINISTER OF AGRICULTURE (SHRI M. V. KRISHNAPPA): In their Second Five Year Plan, the Government of Orissa have included a scheme entitled "Creation of National Park in Mayurbhanj District and Game Sanctuaries". According to available information, the up-to-date expenditure on this scheme is indicated below:

1956-57 Rs. 0-97 lakh 1957-58 Rs. 1-30 lakhs

For the year 1958-59 the figures of actual expenditure are not available, but the estimated expenditure is Rs.1-18 lakhs.

For the year 1959-60 a provision of Rs. 0*75 lakh has been approved by the Planning Commission.

The above figures represent both the Central and the State shares of expenditure.

JAPANESE GARDENS
