The information, therefore, regarding the number of displaced persons at present residing in Karnal Tehsil who may have preferred their claims or rehabilitation grant applications for houses or whose claims or rehabilitation grant applications may have been rejected cannot be supplied. The principles governing the rejection or acceptance of claims or rehabilitation grant applications are of general application and there has been no discriminatory treatment in the case of persons who may have settled 'in Karnal Tehsil.]
