SHRIMATI LAKSHMI MENON: The whole matter is being investigated all that is given in the latter part of the original answer.

SHRI B. K. P. SINHA: May I know whether in those cases in which prosecutions were launched any attempt was made to seize or attach the property of the accused?

SHRIMATI LAKSHMI MENON: In some cases the money has been returned. In other cases where the offences are more serious, they have been sentenced to various terms of imprisonment and some other cases are still under investigation.

SHRI N. M. LINGAM: Apart from tracking down the culprits for which there is provision in law, does not the Government think that it is necessary to absolutely ban such things as they are likely to lower the status of India in the estimation of foreigners because our people extensively indulge in these things?

SHRI JAWAHARLAL NEHRU: I do not quite know how far it is feasible to do that but certainly we will forwara the hon. Member's suggestion to the Home Ministry.

SHRI B. K. P. SINHA: Sir, my question was not answered. My question was whether in those cases ki which prosecutions were launched or in which there have been convictions, any attempt was made to seize or attach the property of the accused.

SHRI JAWAHARLAL NEHRU: We have no information on that subject.

Dr. R. P. DUBE: I want to know whether evidence cannot be taken on commission. Those people who have made complaints cannot come to India but can their evidence be not taken on commission at the places where they are?

SHRIMATI LAKSHMI MENON: This LS not a legal matter.
