In the meantime, certain States have requested for a reconsideration of the issue and the matter is receiving attention.

(d) The award of scholarships will be governed by the Regulations prescribed and instructions issued by the Ministry of Education from time to time.

**COMPULSORY LIFE INSURANCE FOR EMPLOYEES**

<sup>5</sup>127. SHRI V. C. KESAVA RAO: Will the Minister of FINANCE be pleased to state:

(a) whether there is any scheme under Government's consideration for the introduction of compulsory life insurance for Government employees; and

(b) if so, when the scheme will be introduced?

THE DEPUTY MINISTER OF FINANCE (SHRIMATI TARKESHWARI SINHA): (a) and (b). The possibility of evolving a feasible scheme of compulsory insurance for Government employees with special reference to those in the lower income group was examined some time back; but it was felt that any detailed consideration of the matter should await the specific recommendations of the Pay Commission who had already invited views and suggestions regarding the introduction of such a scheme.

**PERMISSION TO INVITE RUSSIAN FOOTBALL TEAM TO TOUR INDIA**

\*128. SHRI MAHESWAR NAIK: Will the Minister of EDUCATION be pleased to state;

(a) whether it is a fact that the All-India Football Federation has asked for Government's permission to invite an official Russian football team to tour India next winter;

(b) if so, what is the foreign exchange required for such a tour; and

(c) what decision Government have taken on the Federation's request?

THE MINISTER OF EDUCATION (DR. K. L. SHRIMALI): (a) to (c). The Federation have been informed that the Government of India have no objection to their inviting a Russian team. The Federation have not asked for any foreign exchange facilities. The foreign exchange requirements, if any, for such a tour, will vary according to the financial terms of the agreement reached between the two parties.
