THE DEPUTY MINISTER OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI MENON): (a) Pakistani forces were first noticed concentrating opposite Dawki towards the end of June. They started unprovoked firing on Dawki from 11 P.M. on 31st July.

(b) We had, both at State and •Central levels, protested to Pakistani .authorities against their threatening • concentration. When the Pakistani forces opened unprovoked firing, our forces retaliated. was arranged between the cease-fire Deputy Commissioners of Shillong and Sylhet on 2nd August. The two Deputy Commissioners met on 4th aijd 5th August . and have decided on measures to reduce tension and prevent further firing.
